CHARGING JAMES MICHEAL CLINE OF  
MURDERING MY MOTHER, SUSAN CLINE BY POISONING

BACKGROUND

1. My mother Susan E. Cline of 11375 Trails Inn Rd died of cancer on Feb. 4, 2017.
2. From 2014-2016 my mother suffered during that time from what was an unexplained illness.
3. On March 2016, doctor at MD Anderson identified and discovered she has three rare types of cancers.
  - A. LYMPHOMA ANIMA
  - B. LL AMLOYDOSIS
  - C. MALDENSTROM MACROGLULINEMIA
4. These three cancerous diagnosis are on the list of conditions that are recognized as exposures of glyphosate chemical, the main ingredient in the weed killer called "RoundUp".
5. At this time 2017, enough research had been done, to show that glyphosate is related to pesticide deaths and many countries completely ban the use of it.

CHRONOLOGICAL FACTS

6. During the months of 2013 I had began to notice her appearance as unhealthy looking with color change to a much paler complexion and eyes looked fatigued, I thinking she looked ran down. I did not say anything to anyone because it was approaching Christmas Season her favorite holiday, and she did work so many hours 37 years day in and day out.
7. In 2014 my mother began openly complaining how awful she was feeling day in and day out. And she said I don't know how much longer I will be able to work.

8. By 2015 my mother has got worse, looked worse, and felt worse. One grand-daughter birthday, March 24, 2015, complaining she and is unable to continue working and is thinking she will have to resigned from her job held at Wal-Mart thirty-seven years that she wanted to continue because she loved her team at Wal-mart and wanted to wait on retirement,

She having no strength to walk and I witness her collapse under her feet.

9. I also noticed Mike Cline was using a new method to make mothers sweet-tea and that they no longer made a full pitcher of that beverage to share but he made individual servings for her and another for himself.

10. I noticed that when James M. Cline made her sweet tea that his concentrate tea was kept in a mason jar, with another gallon of what he said was flush water. I was concerned because so many Equal sweeteners was added to the tea mother was consuming. James was not working anymore a job, except at gardener centers but acting as a personal care giver to my mother who is working and excess of hours at Wal-Mart.

11. In 2013-14 James Cline is involved as a student of online learning through a Missouri Master Garden Program and has begun a flower garden w/bee keeping at the property they abide together in Hindsville Ar. In April 2015 mother resigned Wal-Mart because she was to weak to get up for work.

12. Late Sept 2015 Mother visited me and explained a Bank Deposits at Arvest two location Rogers & Bentonville documents suppose to be there, James M Cline is supposed to take me and documents one being a appraisal for a diamond mother wanted me to have of hers. And all the papers she said James Cline would have them and to go to Stephen Wood Office to sign documents. She said I was named executor and explained James Cline had already wanted her to liquidate many of her Stock Shares that ex-husband Claude West had bought together and in their name, the 5 billion worth investment 1973, that was liquidated and Meryl Lynch as James Cline had prophecy she needed to liquidate her shares.

13. A physician Dr. Swindle eventually in late 2015 told my mom she most definitely has cancer. Somehow a suggested MD Anderson Treatment Centers was discussed, as a way to get best diagnostics. And because doctor could not tell her more than she was Non-Hodgkin

lymphoma at late stages and more involved than that.

14. Susan Cline completed a trip to Houston, using Angel Flights barely able to board a one seater plane, then home again-in Hindsville, Ar. with diagnostic completed, the three types of cancer revealed and the optional treatments they can offer as a treatment plan. Wheel chair needed, not walking and no better than before but worse looking, worse feeling and a plan to return before Christmas to start treatment.

15. Mom completed treatment but not without my having to respond to her SOS January 8, 2016 begging me to come to MD Anderson. She said she did not want to be there and wanted to come home. To call attorney Jim Lingle and ask him does she have to take these treatments? Mr Lingle told me to tell the nurse and doctors what she is asking us. It was a big event and many professionals hearing my mom say to them I don't want.

16. James M Cline explodes on me and tells me I can't stay with me mom now, mothers suggest I drive to Austin Tx visit my brothers and return after husband cools off.

17. Before returning home from MD Anderson, mom said James told her God would call it suicide and she had to do the treatments for him and god. She explained very upset he wanted to change the Trust documents too and add a nephew she never knew of. I told her it's not important to just get home.

18. Susan took a Angel Flight home again-in Hindsville, Arkansas with last trip over Mid-2016

19. Mid 2016 James M. Cline tells me I am to upsetting for visits more than one hour a Sunday so I visit mom on Sunday's.

20. Mom is complaining about the condition of her nail bed and a possible need to treat the condition she is concerned isn't fungus. We get manicures at Kim's Nail they assure her the nails aren't fungus.

21. James Cline was using a lot of LAXATIVES on her and demanded only he was caregiver, mother was very uncomfortable and laxatives he inserts, inside her them. A purpose that kept her on the toilet for hours in pain. He ordered those off Amazon and the yard chemicals at Wal-Mart and Lowes he bought as purchase. As stated, by Mike Cline in deposition.

22. A hand full of dates I arrived to visit with mom when Mike wasn't there. And she mentioned to take items out of the closet from Mikes side a box to my trunk it looked like letters and junk. Other items she was scared he would see her remove and mother told her to put in her car trunk.

23. Mother and I talking agreed June 2016 I should enjoy her bicycle and when Mike heard he was very angry and wanted the item returned this minute, she said sorry.

24. January 14, 2017 a dinner date at Abel's was canceled. My mother said her last dinner event with us, she planned to be handing family members documents but event had to be canceled on account her husband Mike said so, that he was mad at Angela.

25. January 14, 2017 arriving to check on my mother she discussed she was going to die any minute and had no strength to battle with husband. She said go see if Tom Keith will help me and we said good-bye not thinking we see each other again. Crying but James attacked me in front of my mom. He said I belong with the devil.

26. James M.Cline lied to me on Feb 4, 2017 in a private conversation. This was months before a deposition when a conversation between us: "Mike at least if my mother died young, she had a beautiful garden and a Master Gardener for a husband."

James "Mike" Cline surprised me by quickly making a mummer response that he not is a Master Gardener.

But he is, I know that he did research and where it was submitted. My mom was proud of every detail of her accomplishments or her husband's, education, employment, the beautiful garden at War Eagle Bed & Breakfast that he maintained for her, that was favorite, sitting in her garden, with sweet tea that he alone exclusively prepared for her by individual servings.

27. RoundUp Chemical was in her tea cup covered in Equal. Thus, sweetened to a flavorful beverage. James Cline was using a lot of laxatives on her while he demanded only he was caregiver, mother was very uncomfortable and laxatives he shoved them in her for a purpose, keeping her on the toilet for hours in pain. James ordered those off Amazon I saw the truck deliver more, and the yard chemicals at Wal-Mart and Lowes he bought as purchase. As stated, by Mike Cline in deposition.

28. Mike Cline's casual remarks after 2/4/2017 to family members just after her death, one such remark:

Susan's grandson was told, he knew he needed to talk to god because he was certain that with Susan "gone now, he wouldn't get the attention he enjoyed".

29. I think he must have something like a caregiver by-proxy disorder.

But it reminded me, my mother saying how much he enjoyed her being sick", said he "thrived on attention" Late December 2016 at a holiday gathering

and later she said again first of January 2017 "something in this house is killing me".

30. In 2017 deposition James Cline was asked why he lied about being a gardener.

Mike at deposition admitted, "yes I am" Master Gardener". But, stated he doesn't "feel like one", whatever that is suppose to mean, 'I don't feel like one" I am not sure how one feels to be a Master Gardener. You are or you are not. It's like being a police officer I might guess you become that in a process of efforts including hours and hours of training.

31. James Micheal Cline never intended to honor the prepared documents a Revocable Trust between husband & wife. And James M. Cline moved the property deed from the Trust estate to himself deeded hours before my mother expires with his knowledge only as she lay unconscious, disassembling the Trust before it is ever funded. A Sham.

#### FINAL STATEMENT

I sought out help on several dates to report that my mother's death was suspicious. I believe that Susan E. Cline, had been poisoned in a long campaign of subterfuges.

Past History -I found polaroid pictures he put in the trash can 1978 when dating my mother, the kitchen trash, photographs of my mom naked and/or playing dead or drugged. My mom was not a drug user that I knew of. She was a business woman and single divorced with two-children. Photo fantasy or game or drugged unintentional whatever but, she also said he's promised to stay away from children church groups. The first thing I noticed after mothers funeral James Cline involved in children church ministry and spend overs with the hispanic maids little daughter(s). Candy Ice Cream and lots of Smiles.
